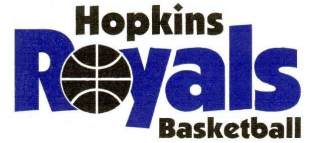




# HOPKINS GIRLS BASKETBALL JAMBOREE 2010

## Schedule:
